

Attention Los Angeles County Sheriff Alex Villanueva,

We the undersigned stand in solidarity with you, our LA County Sheriff, in upholding your lawful duty to remove members of the Board of Supervisors and the Health Directors from their positions as public servants.

When these two entities failed to do their lawful duty to refuse Governor Gavin Newsom's unlawful edict, and they instead handed that down to the population of Los Angeles County as unlawful mandates, **they became subject to permanent removal according to their legally-binding Oath of Office to uphold and defend the Constitution of the United States of America.**¹

By forcing the closure of small businesses while allowing big box stores to continue operating, they violated the right of US citizens to earn a living. By forcing the covering of our airways with masks disproven² to work in peer-reviewed clinical trials and indeed to be deadly, they weakened our immune systems and caused us anxiety from lack of oxygen. By forcing arbitrary, unsubstantiated 'social distancing' and disallowing us to meet and gather together, they violated our Constitutional right to free assembly. At no time have any of us been presented with scientifically peer-reviewed clinical trials that demonstrate there is a pandemic, that masks work against viruses, or that social distancing, business closures, or 'lock downs' are effective. Regardless, as stated in the Constitution itself, the Constitution is NOT suspended in a crisis. Therefore, all forced measures handed down by the LAC BOS and HD broke the law by treating our rights as disposable and secondary to the 'COVID-19' narrative.

Furthermore, we have on our delegation an eye witness with many years of experience in local government, who personally knows one of the three founders of Black Lives Matter, Patrice Cullors. He was present when BLM brought a team of paid lobbyists to months of Board of Supervisors meetings to advocate the defunding of the LASD. As you are well aware, they achieved this goal, **resulting in the financial weakening of your ability to do your duty in upholding the laws of the United States, California, and Los Angeles County by a special-interest group, NOT BY YOUR CONSTITUENTS.**

This highly questionable defunding of the LA County Sheriff's Department puts LAC residents in the path of hundreds of thousands of cartel and gang members, human traffickers, and drug smugglers pouring unchecked through our southern border. The defunding of The People's county sheriff also puts the constituents who elected you in extreme danger of being raped or killed at the hands of the over 83,000 convicted murderers and rapists released from prison by Governor Newsom, following the defunding of the LASD.

Governor Newsom is also subject to permanent removal by your department for his violations of his Oath of Office, by the way. Governors cannot make laws. Boards of Supervisors cannot make laws. Health Directors cannot make laws. Legislators are the sole entities granted the power to do so. And any law which goes against the Constitution is null and void.

It is in consideration of these startling but authentic facts that We the People of Los Angeles County hereby voice our support of you, our public servant and county Sheriff, in the correct and lawful execution of your duties as chief law enforcement officer.

Namely, we not only stand behind you but we peacefully demand your immediate and permanent removal from public office of the parties named above.
