## THE KEY



Constituents have the right to have any public servant PERMANENTLY REMOVED from serving in government. The law that allows us to do this is called the Oath of Office. Any public servant who violates this Oath forfeits their position, bars them from ever holding office again, and revokes their pension.



5 U.S. Code § 3331 - Oath of office

An individual elected or appointed to an office of honor or profit in the civil service or uniformed services, shall take the following oath: "I, AB, do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservation or purpose of evasion; and that I will well and faithfully discharge the duties of the office on which I am about to enter. So help me God."




**Befriend your county Sheriff.** It is the sworn duty and legal responsibility of all sheriffs in the United States to know, follow, and defend the Constitution. This makes sheriffs our most powerful allies. Most patriots are attacking or serving sheriffs, which makes this approach even more effective in contrast.

**How to get your sheriff on your side.** To persuade anyone, you must address their needs and goals and avoid talking about yourself until asked. By prioritizing the needs and goals of our sheriffs first, we pave the way for him or her to consider ours.

**We Have A Golden Opportunity.** Sheriff's as well as police departments have been defunded across the country, not by constituents, but by a paid, special-interest lobbying organization, Black Lives Matter.

In Los Angeles County, the Board of Supervisors allowed BLM to convince them to defund the LASD, without constituent knowledge or consent. We can protect our sheriff's independence from the Board of Supervisors stepping on his lawful authority by reminding him that by doing his lawful duty and removing them\* he has a good chance of regaining his funding by a non-corrupt replacement board. The golden opportunity is twofold, in that the legal grounds for removal of said public servants by the sheriff is their acceptance of unlawful edicts from the governor and creation of unlawful mandates that violate constituents' Constitutional rights to assemble and operate a business, etc. It is a shining silver lining to the dark cloud descending around us in America right now. We the People MUST seize this opportunity as the gift it is. Do this by standing by our sheriff in his lawful duties as an empowered, informed citizen who understands precisely what happened and what needs to be done. Approach your sheriff with respect and cooperation, and he will likely listen and work with you.



## IF LUCKY



**What to do if your sheriff is Constitutional,** i.e. is doing his duty under the law. You can use letters or affidavits to document the violations of your public servants, or simply set a meeting with your sheriff and tell him about the violations. Ask your sheriff to enforce the law by removing the public servants from office.

If your sheriff is willing to help but doesn't know the law, rather than threatening him with removal or making angry demands, approach the subject in a peaceful and cooperative manner. Sheriff Mack, founder of the Constitutional Sheriff's and Peace Officers Association, has offered to provide a free training to all sheriffs and their deputies. The training instructs these vital public servants in their lawful duty and power under the United States Constitution, the highest law of the land. Work with your sheriff's department and the CSPOA to set up and hold this training.

## CONTINGENCY



**What to do if your sheriff is not** or will not uphold his Oath of Office. Like perhaps many other Oath-violating public servants, many sheriffs no longer know their lawful duty. If he refuses to heed your peaceful demand, you can then seek any other sheriff's assistance in removing your sheriff. There are 3,000 sheriffs in the United States, and not all of them are corrupt! Reach out to one who is correctly doing and knows his duty under the law. Or, you can make a personal arrest of any and all public servants, including your sheriff. Note that removal is far more powerful than arrest because it is permanent while arrest allows a former public servant to run for office in the future.

## PROOF OF CONCEPT



The delegation I created to execute this plan in my county has on-hand a Constitutional lawyer who is an expert at the Oath of Office. I also happen to be good friends with a former city council member who witnessed the defunding of the LASD and who also personally knew BLM founder Patrice Cullors at the time she took the money from George Soros used to pay BLM lobbyists to defund the LASD.
